#### What are cookies?

Cookies are really useful because they allow our website to 'recognise' you via your device and recall your settings and preferences from previous visits. This helps us in a number of ways, explained in the next section.

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive.

### How does Go Climate Positive Limited use cookies?

The first time you visit our website via a particular device (e.g. your laptop or mobile), we will provide a clear on-screen notification about our cookies and give you the choice if you accept them, decline them or find out more.

If you accept cookies our website will place the relevant cookies on your device. The next time you visit the website, your device will check to find the relevant cookies and, if your device has them, it sends the cookie information back to the website.

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site. By continuing to browse the site, you are agreeing to our use of cookies.
